

<p><b>Terms and Conditions for Participating in the GOLDEN TRAIL NATIONAL SERIES UNITED STATES &amp; CANADA ("Terms")</b></p>
---

**1. General Terms**

By participating in the GOLDEN TRAIL NATIONAL SERIES UNITED STATES & CANADA ("Promotion"), you accept these Terms. Please read these Terms carefully before participating. If you do not agree to the Terms, you may not participate in the Promotion.

These Terms govern the relationship between you ("you" or the "Participant") and "AMER SPORTS NORTH AMERICA" 2030 Lincoln Ave. Ogden, UT 84403 [contact-nam@goldentrailseries.com](mailto:contact-nam@goldentrailseries.com) ("Organizer") in relation to the Promotion. Questions and feedback about the Promotion may be brought to the attention of Organizer through the aforementioned contact details.

The Promotion begins on 02/16/2021 at 6am MST and ends on 09/31/2021 at 6am MST

The Promotion promotes the trail-running and the GOLDEN TRAIL SERIES.

**2. Right to Participate**

The Promotion is open to individuals who are legal residents of Austria, Canada, Finland, France, Germany, Japan, The Netherlands, Russia, South Korea, Spain, Sweden, Switzerland, United Kingdom, and USA who are born in 1998 and over. The Organizer may require winners to certify their eligibility to participate in the Promotion.

All the members of the Organization Committee are not eligible to participate in the Promotion. Any illegible entries will be held void.

**3. Instructions for Participation**

Runners must participate in at least 2 out of 4 qualifying races and reach the top 3 to be invited to the GTNS USA/CAN national final. The overall ranking will take into account each runner's 2 best results from the qualifying races (Quebec Mega Trail, Pikes Peak Marathon, Way Too Cool, Whistler Alpine Meadows) + the result of the national final - Broken Arrow Skyrace

The GTNS USA/CAN top 3 men and women in the overall ranking will receive tickets\* for the GTNS Grand Finale, "Triangle Adventure" organized by Azores Trail Run from the 22/10/2021 to the 24/10/2021.

In the event there is a tie:

- 1- The best place on one of the GTNS USA/CAN 2021 qualifying race
- 2- The second place on one of the GTNS USA/CAN 2021 qualifying race
- 3- The third place on one of the GTNS USA/CAN 2021 qualifying race

This GTNS Grand Finale will gather all the different GTNS (GTNS USA/CAN GTNS FR-BEL / GTNS SP-POR/ GTNS IT / GTNS UK / GTNS CZE-SK-POL etc.). If a runner didn't reach the top 3 in the national final to receive an invitation to the GTNS Grand Finale, he/she can still go at his/her own expense. The top 3 men and women from this GTNS Grand Finale will win a Golden Pass\* to participate in the Golden Trail Championship 2022, under the condition that he/she has participated in one of the GTNS 2021.

In the event of injury and the inability to compete before the competition, the runner who would have won a ticket for the GTNS Grand Final, or for the GTC, will not receive any compensation and will lose his/her ticket and will not receive travel expenses.

In the event races are cancelled, the rules will be modified as follows:

No responsibility is accepted for late, lost, delayed, damaged, corrupted, illegible or incomplete entry forms, which shall be disqualified at the discretion of the Organizer, or for transmission or computer error affecting the logging of entry forms. Proof of posting will not be accepted as proof of delivery.

#### 4. Selection of Winner

The winners of the Promotion will be determined on 10/24/2021. The winners will be notified no later than on 11/01/2021 directly by the Organizer by e-mail and/or by phone. The prize will be delivered to the winners 11/01/2021.

The names of the winners will also be published on [www.goldentrailseries.com](http://www.goldentrailseries.com) to the extent the winners have not prohibited the publication of their names. By entering this Promotion, you agree to such publication of your name if you are a winner. You are allowed to withdraw your consent at any time. If a winner cannot be reached within three (3) business days as of the date on which the Organizer first attempted to reach the winner, or if the Organizer has reasonable grounds for believing that an entrant has contravened any of these Terms, the initial winner will be considered to have forfeited their right to the prize and the Organizer is entitled to select another winner. The Organizer's decision(s) are final and no correspondence shall be entered into.

## 5. Prizes

The first 3 men and women from the GTNS USA/CAN overall ranking will receive their tickets\* to participate in the GTNS Grand Finale. Therefore, they will receive financial support for transport and accommodation.

The first 3 men and women from the GTNS Grand Finale will receive their Golden Pass for the Golden Trail Championship 2022. Therefore, they will receive financial support up to the maximum sum specified in the GTC 2022 rules to participate in the Championship and receive free and guaranteed race bib.

*\*Ticket= race bib+ transport+ accommodation in the maximum sum specified. Up to €600 from Europe to Europe and up to €1,200 from overseas.*

### TOUR PRICE DOES NOT INCLUDE

- All drinks
- All items of a personal nature
- All gratuities for guides, drivers and hotel staff
- Any other services not mentioned above
- Transport from/to the race location
- Parking for their car in any situation
- Personal insurance

Moreover, in order to validate their Prize, the Winner shall provide the Organizer within 2 weeks from the time they have been informed about their win with the following information:
