## **Terms and Conditions for Participating in the Salomon Golden Trail National Series event ("Terms")**

### **1. General Terms**

By participating in the Salomon Golden Trail National Series event ("**GTNS**"), you accept these Terms. Please read these Terms carefully before participating. If you do not agree to the Terms, you may not participate in the GTNS.

These Terms govern the relationship between you ("**you**" or the "**Participant**") and Amer Sports Danmark ApS, with the CVR number 11980899, having its registered address at Kokkedal Industripark 14, 2980 Kokkedal, Denmark, with the contact information contact-nordics@goldentrailseries.com ("**AS Danmark**") in relation to the GTNS. Questions and feedback about the GTNS may be brought to the attention of AS Danmark through the aforementioned contact details.

The registration to the GTNS begins on 15 March 2021 at 18:00 (CET) and ends on 6<sup>th</sup> of May 2021 at 23:59 (CET) (inclusive) ("**GTNS Registration Period**"). Only entries received within the GTNS Registration Period will be taken into account.

AS Danmark organizes the GTNS as described in these Terms. Due to possible Covid-19 restrictions, see the applicable alternate terms\* below.

The GTNS promotes trail running, the Golden Trail Series and Salomon brand.

### **2. Right to Participate**

The GTNS is open to individuals who are legal residents in Denmark and who are over the age of majority in their jurisdiction of residence. AS Danmark may require winners to certify their eligibility to participate in the GTNS.

All the members of the GTNS Organization Committee are not eligible to participate in the GTNS. Any illegible entries will be held void.

Only the winners of the GTNS has the right to participate in the GTNS Grand Finale organized in Finland (see below).

### **3. Instructions for Participation**

GTNS is organized in cooperation with Hammertrail event. This means that AS Danmark is the organizer of GTNS whilst the GTNS is organized in cooperation with Hammertrail organization committee. By participating in the Hammertrail in the distance of 33 kilometers the Participant will also attend to the GTNS. The winners of GTNS will get to participate in the GTNS Grand Finale (see below in parts 4 and 5).

If you are selected as a winner of GTNS, you allow AS Danmark to use and distribute your name and use, reproduce, modify, adapt, publish and display your submission/photo/etc. as well as

biographical information, photographs, video recordings, statements, and other such materials of you in its advertising and marketing in website and social medias worldwide for a period of 10 years from selection of the winner for advertising and marketing purposes without any further remuneration or separate agreements to the extent permitted by mandatory law. In doing so, AS Danmark will acknowledge you to the extent required under applicable mandatory law.

Participation in the GTNS is not subject to any extra charge to AS Danmark.

Any illegible or fraudulent entries will be rejected. If you enter or attempt to enter the GTNS in violation of these Terms or in a manner that is otherwise unfair to other participants, you may be rejected from the GTNS at AS Danmark's sole discretion.

No responsibility is accepted for late, lost, delayed, damaged, corrupted, illegible or incomplete entry forms, which shall be disqualified at the discretion of AS Danmark, or for transmission or computer error affecting the logging of entry forms. Proof of posting will not be accepted as proof of delivery.

#### **4. Selection of Winner**

In both the GTNS and GTNS Grand Finale the fastest runners in the women's and men's series will be selected as the winners.

The winners of GTNS will be determined on 8 May 2021. The winners will be notified no later than after the race held on 8 May 2021. The prize will be delivered to the winners on 8 May 2021. The winners from GTNS will get to participate in the GTNS Grand Finale.

The winners of GTNS Grand Finale will be determined on 4 September 2021. The winners will be notified no later than after the race held on 4 September 2021. The prize will be delivered to the winners on 4 September 2021.

The names of the winners will also be published on Hammertrail web site, [www.salomon.com](http://www.salomon.com) and Salomon social media to the extent the winners have not prohibited the publication of their names. By entering this GTNS, you agree to such publication of your name if you are a winner. You are allowed to withdraw your consent at any time. If a winner cannot be reached within three (3) business days as of the date on which AS Danmark first attempted to reach the winner, or if AS Danmark has reasonable grounds for believing that an entrant has contravened any of these Terms, the initial winner will be considered to have forfeited their right to the prize and AS Danmark is entitled to select another winner. AS Danmark's decision(s) are final and no correspondence shall be entered into.

#### **5. Prizes**

GTNS

The fastest runners in the women's and men's series will receive their tickets to participate in the GTNS Grand Finale organized in Finland. GTNS Grand Finale will be organized by Amer Sports Suomi Oy together with the event organizer Nuuksio Classic Trail Marathon on 4 September 2021. Therefore, the Winners will receive financial support for participation, transport and accommodation.

The prize includes: Nuuksio Classic Trail Marathon race bib number worth of DKK 610, transportation to the avenue and back worth of DKK 1115 (approx.) and the accommodation for one (1) night worth of EUR 1115 (approx.) and flight tickets to Finland.

#### GTNS Grand Finale

The fastest runners in the women's and men's series will receive their Golden Pass for the GTNS Grand Final Azores Trail Run, organized in Azores, Portugal, on 22.–24.10.2021.

The prize includes: guaranteed race bib number, transportation to the avenue and back, and the accommodation for one (1) night worth of DKK 11150 (approx.) in total.

Moreover, in order to validate their Prize defined above, the Winners shall provide AS Danmark within 2 weeks from the time they have been informed about their win with the following information:

- 1) A signed declaration and release form confirming compliance with the Contest Rules and acceptance of the Prize as offered; acknowledging the non-responsibility of AS Danmark with respect to injuries, accident, loss or misfortune relating to the Prize; and acknowledging the right of AS Danmark to publish or broadcast worldwide the Winner's pictures, videos, name and statements without charge or further compensation other than the Prize offered.
- 2) A copy of their unexpired Identity Card.
- 3) Any other information required to deliver the Prize.

If the Winners do not provide the above-mentioned information within 2 weeks, they will be considered of having waived their Prize and the Prize will not be awarded. Any and all other costs, expenses etc. will not be borne by AS Danmark.

The Prizes are personal, non-exchangeable, non-transferable and non-refundable. No cash alternative is available. To the extent not prohibited under applicable mandatory law, **you will be solely responsible for all applicable taxes relating to your receipt and/or use of the prize**, if applicable. AS Danmark will give notifications to tax authorities and pay any taxes that it is obliged to pay in accordance with applicable mandatory law.

Unless otherwise provided under applicable mandatory law or expressly stated in writing in connection with the distribution of the prize, the prize is awarded on an "as is" basis and AS Danmark, nor any of its affiliates, makes any representations or warranties of any nature with respect to the prize.

AS Danmark reserves the right to defer the date of delivery of any of the Prizes, in the event the GTNS Grand Final Azores Trail Run is cancelled and/or postponed due to unforeseeable and unavoidable circumstances beyond the reasonable control of the event organizer and/or AS Danmark including, but not limited to, epidemics or pandemics, any law or any action taken by a government or public authority, or lockouts.

## **6. Liability**

Nothing in these Terms shall exclude or in any way limit AS Danmark's liability for fraud, or for death or personal injury caused by AS Danmark's negligence or any other liability to the extent the same may not be excluded or limited as a matter of law. Some jurisdictions may not permit limitations of certain rights, claims, implied warranties or types of damages. Some of the following limitations may, therefore, not apply to you.

Subject to previous section, the following shall apply. To the extent permitted by applicable mandatory law, by participating in the GTNS, you agree to release AS Danmark and its affiliates from any and all liability arising in any manner out of the GTNS including, without limitation, the selection of the winner, the administration of the GTNS, and the acceptance or the use of the prize or any component thereof as well as to indemnify and hold AS Danmark and its affiliates harmless from and against any claims, damages, liabilities, losses, costs or expenses arising from, or attributable to, any of your acts or omissions relating to the GTNS. Except in the event of gross negligence or willful misconduct, AS Danmark's and/or its affiliates' liability will in any case be limited to the value of the prize to the extent permitted by applicable mandatory law.

## **7. Dispute Resolution**

These Terms shall be governed by the laws of Denmark.

If you have a complaint relating to these Terms, we will attempt to resolve the complaint internally. Ultimately, any dispute shall be brought before the Court of first instance with jurisdiction over the place where you are a legal resident.

If a dispute, conflict or controversy arising out of, or in connection with this GTNS, cannot be resolved through negotiation between the parties, the European Commission provides a platform for online dispute settlement. This gives you the opportunity to settle disputes in connection with these Terms without first engaging a court. The platform can be found at <http://ec.europa.eu/consumers/odr/>. The consumer can also submit the matter for resolution to a competent national dispute resolution body.
